





NO SMOKING POLICY



Althana Group of Companies encourages all its employees to practice good health habits and discourage the use of tobacco in any form which will affect the person's health and other's in form of passive smoking.

This policy applies to all employees of Althana Group of Companies as well as to visitors, contractors and temporary staff. We believe that the right to clean air and the health of non-smokers supersedes the right of others to smoke. Therefore, we clearly state that the company must be smoke and tobacco free at all times.

Along with the protection to non-smokers from the hazard of passive smoking, the reasons for enforcing this policy are various as follows:



- To safeguard the legality of the company by adhering to relevant legislation of sultanate of Oman.
- To limit the probability of fires started by improperly discarded cigarettes, cigars etc.
- To avoid falsely setting off alarms and smoke detectors
- To preserve the image of a clean workplace without unpleasant smells or smoking-related trash

For these reasons, smoking is strictly prohibited indoors and outdoors at company facilities unless there is a designated area especially for this purpose. This non-smoking policy covers all premises including bathrooms, hallways, staircases etc. It also includes company property that is leased or owned by the company (warehouses, vehicles etc.). The prohibition is in effect before, after and during working hours.

Smoking may be permitted during normal breaks and only at the Designated smoking areas/rooms and the employees who are smoking at the Designated smoking areas/rooms have to always extinguish their cigarettes and other smoking material (e.g. matches) and discard them only in appropriate containers.

At any time, smokers are advised to respect their fellow people by keeping a safe distance from them. Employees will be thoroughly informed of the guidelines of this policy through official bulletin boards, company newsletters or posts and appropriate signs. Employees who welcome visitors or clients on company premises are obliged to inform them of our non-smoking policy and point them to the designated smoking areas.

Employees who disregard the guidelines of this smoking policy will be subject to disciplinary procedures including termination from service depending on the severity or the frequency of the offense. This policy will be enforced with documented management commitment and review, supported through supervision and complied with by all personnel.

SAFE DRIVING POLICY



The risk of injury to employees and damage to property as a result of accidents while employees are driving Group's vehicles or operating mobile construction equipment are well recognized.

Althana Group of Companies is committed to the safety of its employees and third parties and has the ultimate goal of achieving Zero Accidents due to driving of vehicles and operation of mobile equipment.

The purpose of this policy is to reduce injuries and property loss by promoting a safe driving culture within the Group.



All employees and contractors of The Group are required to adhere to this policy when driving or operating Group owned or leased vehicles/mobile equipment as well as when driving their personal vehicles during business use.

Our Commitment

- Provide Group owned or leased vehicles, with all legal documentation for use by employee/driver.
- Ensure all Group owned and leased vehicles are well maintained, in good running condition, suitable for the purpose and equipped with the necessary safety and emergency devices.
- Record and analyze accidents with a view to identifying root causes and define corrective and preventive measures to avoid their reoccurrence.

The following control measures must be implemented, in conjunction with local and international traffic regulations.

- Sultanate of Oman Traffic Rules & Regulations and Al's HSEMS will be applicable for vehicle driving and operating of equipment within the Group premises.
- Driver must have a valid driving license for the class of vehicle to be driven/operated.
- Driver must be physically able to perform the duties of driving or operating equipment.
- Vehicles shall be parked at designated areas only and reverse parking is mandatory whenever indicated.
- The Group controlled roads shall be designed according to local regulations and standards and provided with suitable safety signage.
- Transportation of heavy equipment shall be carefully planned, supervised and controlled to manage and reduce associated risks.
- Behaviour of Group and contractors employees will be monitored. A reward/penalty system will be implemented based on individual's driving behaviour.
- Driver should be aware of weather forecast and road conditions on a planned journey and, if required, rearrange the journey in case of adverse conditions.
- Driver and passengers must wear seat belts at all times.
- Driver must not exceed speed limits and obey local traffic laws.
- Driver must maintain a safe stopping distance from the vehicle in front.
- Driver must not use a hand held phone while driving.
- Driver must have a list of emergency contacts in the vehicle who can be immediately contacted in case of accidents or in emergency situations.
- Driving under influence of alcohol, drugs or other controlled substances is strictly prohibited.
- This policy is mandatory for employees and will be reaffirmed and measured by management on a regular basis.
